Health Department, First Choice Healthcare and Henry County Farm Bureau to Hold Special DOT Exam Clinic on February 21

The Henry County Health Department, First Choice Healthcare, and the Henry County Farm Bureau remind Farm Bureau Members they will be holding a special Certified DOT Exam Clinic for all Henry County Farm Bureau members on Friday, February 21st at the Henry County Farm Bureau, 128 N Prospect St., Cambridge. The clinic is open to all men and women 18 years of age and older.

The special clinic will be featuring Certified DOT Exams for only \$115. The Department will also offer Tetanus Booster Shots for \$25. Tetanus boosters are recommended every 10 years in adulthood. Professions and activities strongly encouraged to stay up-to-date on tetanus vaccination include: farming, construction, healthcare, childcare, food handling and gardening.

Appointments for the February 21st clinic are necessary and will be accepted on a first come, first served basis. Please note, these DOT Exams and Tetanus Shot specials are available on a "Cash Only" basis and the Farm Bureau Discount has already been applied. To schedule an appointment, or for more information on the upcoming Henry County Farm Bureau DOT Exam Clinic, call the Farm Bureau at (309) 937-2411.

Health Department and First Choice Healthcare staff note that the Department of Transportation requires some drivers to get regular physicals to make sure they can drive safely. If any of the following apply to you, you must get a DOT physical and carry a DOT medical certificate when you drive a commercial vehicle:

- You are paid to operate a motor vehicle that holds nine to 15 passengers; you drive the vehicle more than 75 miles from where you report to work; you operate this vehicle for interstate commerce purposes
- You operate a motor vehicle with a gross combination weight rating, gross vehicle weight, gross vehicle weight rating,

or gross combination weight of at least 10,001 pounds; you operate this vehicle for interstate commerce purposes

• You transport hazardous materials in certain quantities

In addition, those who are seeing a provider and are on medication for sleep apnea, diabetes, high blood pressure, cardiac, anxiety, ADHD/ADD, depression and other mental health issues, and seizures. Participants need to obtain a "Clearance Letter" from the provider of care and bring to their appointment. Those forms will be made available to participants when they register for the February 21st clinic.

In addition to the exams & vaccination services, the clinic will feature free donuts, coffee and juice courtesy of the Henry County Farm Bureau. A variety of health pamphlets, brochures and giveaways will also be on display.

In keeping with the Health Department's mission of promoting healthier living, the Health Department's Farm Bureau Health Check Clinic will be featuring a combination General Health/Thyroid & Lipid Panel Blood Test for only \$50. This test offers 45 results, including a full lipid "Cholesterol" panel. Please note, fasting is recommended for this test for optimum results.

The Department will offer a \$10 Prostate

Specific Antigen (PSA) test for men aged 50-64. In addition, free blood pressure checks will also be available to clinic participants.

Appointments for the March 7th clinic are necessary and will be accepted on a first come, first served basis. Please note, these lab specials are available on a "Cash Only" basis and the Farm Bureau Discount has already been applied.

SNOWY SCENES LIVEN LANDSCAPES

A light snow arrived after New Year's Day, and my soul cued up the song "Snow" from Irving Berlin's musical, White Christmas. The white stuff compelled me to plug our exterior Christmas lights back in after previously retiring them for the season. I wanted photos of our lit, snow-capped roof line and the warm white lights glowing through the snowy bushes.

Yes, snow sometimes deserves the four-letter word status, but forget about the wet boots at the back door, the treacherous road conditions or the livestock and barnyards that need scooped out. Disregard the people who escape to Florida because of it or the life-altering chaos of breaking both arms while sledding with your kids in a cattle pasture (yeah, that happened to someone).

Enjoyed in the moment, snow brings peace. It delivers calmness. The precipitation generates a serene feeling unmatched in any other season. It makes us crave beef roast and chicken pot pie, a fire in the fireplace, a blanket and a book. The snowy landscape glistens, producing reflections at sunrise that rival bodies of water. The white stuff magically turns barrenness to beauty, and the glow of a barnyard light on a fresh batch defines silent night – calm and bright.

During my country travels, I appreciate the high contrast as the snow accents every leafless branch of a tree. It adds elegance to everything brown and provides evidence of presence by humans, wildlife, tractors, sleds and snowmobiles. While our chickens hesitate to step out of the coop when they see a carpet of white, our cows stand majestically beautiful and undeterred with snow on their backs.

Freshly fallen snow likens a new jar of peanut butter, highly tempting to disturb. The kids eagerly oblige. Snow spawns some of our fondest family memories of snowmen, sledding, hot cocoa and days off school. In fact, my transplanted Illinois family that lives in southern California escapes to the mountains to find snow and play in it.

Mom said our region experienced the blizzard of a lifetime one week after my birth. More than two feet of snow and high-wind conditions made Dad crawl down the roadside to work, following the tops of the fence posts that peaked from the snow. Roads were impassable or allowed a single lane for traffic only because road crews recruited the support of end loaders to make a path. We don't need too much of a good thing.



Fourth grade students at Cambridge Elementary School watched a video of how candy canes are made and learned about mint plants and enjoyed a candy cane snack.




FARM BUREAU WOMEN HOST CLASS

HENRY COUNTY FARM BUREAU FOUNDATION TO AWARD \$50,000 IN SCHOLARSHIPS

The Henry County Farm Bureau Foundation is offering up to eight scholarships, at a minimum of \$1,500. In addition, Farm Bureau will be administering the following scholarships: Wilbert and Carol Keppy Foundation, three each in the amount of \$5,000; Kevin and Karen Urick Farm Bureau Legacy Scholarship, in the amount of \$1,000; Glenn and Betty DeSmith Memorial Scholarship, three in the amount of \$5,000 each; Trade and Technical Program Scholarship, up to six in the amount of \$1,000 each; James Ufkin Memorial Scholarship, in the amount of \$1,000.

The Henry County Farm Bureau Foundation was formed in the Spring of 1984 to carry out charitable, scientific, literary, and educational work in the field of agriculture. The Foundation awards scholarships each year to graduating high school seniors and college students pursing degrees in Agriculture.



Wilbert and Carol Keppy farmed and raised hogs along the Osco slab for decades. The Keppy's were instrumental in starting the Henry County Pork Producers and were among a group of pork producers throughout the state that started the Illinois Pork Producers in the early 1960s. The Keppy Foundation annually provides scholarships for students in Henry County. the Urick family for multiple generations. This scholarship is designed to honor the organization that has served as an educational, social, and economic tool for its members, as the "Voice of Agriculture" in Henry County, since 1917.



The Glenn and Betty DeSmith Memorial Scholarship honors the life of Glenn and Betty DeSmith of Geneseo. Glenn proudly served his country in the Army during the Korean War from January 1951 to January 1953. The DeSmith's farmed southwest of Annawan until their retirement in 1990. Glenn and Betty were very active in the community and their church. Glenn served on the Henry County Farm Bureau Board and the Henry County Soil and Water Conservation District Board, receiving the Henry County Conservation award in 1975. The DeSmith Memorial Scholarship recognizes students who are involved in the livestock industry and their family



time Jim also served on the Board of the Henry County Farm Bureau Foundation. Mr. Ufkin was a dedicated leader in the agriculture community in Henry County and beyond.

This year the HCFB Foundation Board is proud to announce, for the third year, that they will award those pursuing a skill in a "Trade and Technical Program." Up to six scholarships will be awarded, at a minimum of \$1,000 each, to individuals enrolled in a program and seeking skills benefiting agriculture in the area of study including, but not limited to, truck driving, welding, electrical, plumbing, carpentry, HVAC, etc.

Any student who qualifies under the guidelines may submit an application for either or all scholarships. Applications will be judged separately.

Applications must be received by or postmarked to the Henry County Farm Bureau® office, 128 N. Prospect Street, Cambridge, by March 7. 2025. The Foundation Board will make the final selections after the deadline.

RECIPE OF THE MONTH

CHICKEN AND NOODLES

Reprinted from the 50th Anniversary Farm Bureau Women's Cookbook

From the kitchen of Mrs. Warren Beuster (Kewanee)

Ingredients:

- 1 large chicken, cut up
- 6 bay leaves
- 6 cloves

Directions:

- 1 whole onion
- ½ c. flour
- ¾ c. sour milk
- 2/3 c. vinegar
- 1 egg, beaten
- 1 pkg. wide noodles

Boil chicken in just enough water to cover it. Put in salt, bay leaves, cloves and onion. Take chicken out when done and let broth boil down. Beat egg. Make a paste of flour and sour milk, add egg, then add to broth. Add vinegar to taste. Boil noodles separately in salt water, then drain. Serve separately with gravy over noodles.

Recommendations centered around three strategic initiatives - representation, engagement and organizational strength - and they include pilot projects, behind-the-scenes efficiencies, and expanded programming for members. Four of the recommendations require bylaw changes and will be voted upon by delegates at the 2025 IFB Annual Meeting. Two of those focus on membership – simplifying all memberships into two categories: voting and supporting members – and two other recommendations involve streamlining dues and membership processing.

All recommendations were made by the OMS Advisory Committee and three subcommittees, comprised of Farm Bureau members and Young Leaders, county managers and presidents, IAA directors, and IFB staff, and then approved by the IFB Board of Directors.

The committee based the recommendations on member data from nearly 4,000 survey responses and more than 40 in-person focus groups. IFB staff traveled more than 7,500 miles meeting with members and collecting the data from across the state.

"We enjoyed hearing the vision our members have for the future, and this roadmap is a starting point for how we will turn that vision into reality," said Lyndsey Ramsey, IFB's director of organizational strategy.



The roadmap will be implemented and evaluated over the next three years. The OMS Advisory Committee will continue to meet regularly to evaluate progress and examine additional ideas for recommendations. Feedback is welcomed at oms@ilfb.org.
